

The Government Performance of Dr. Bishr Al-Khasawneh during the 14 months of its Formation Brief

Al-Hayat Center - RASED launches its fifth report of its kind on monitoring performance for the government of Dr. Bishr Al-Khasawneh, which is implemented by RASED team to monitor government performance, covering a period of 14 months from 10/12/2020 to 11/12/2021. This report provides quantitative and qualitative information and facts. It was collected and analyzed according to scientific and objective methodologies, and based on a set of international best practices in this context, noting that RASED issued its first report to monitor the Khasawneh government during the end of the first 100 days, its second report after six months, its third report after nine months, and its fourth report "a year after the formation of the government.

This report provides a qualitative analysis of the performance of the Khasawneh government during the fourteenth-month period of its formation. The report also provided a qualitative analysis targeting stakeholders and a variety of experts on their assessment of government performance through telephone interviews and focus groups sessions.

The Government Performance of Dr. Bishr Al-Khasawneh during the 14 months of its Formation

The report contains an analysis of all the decisions taken by the Khasawneh government during the fourteen months of its formation, as the number of decisions taken by the Council of Ministers reached 424, and the decisions were collected from official sources published in the Official Gazette, where they were studied and analyzed based on several main axes.

The decisions issued by the Khasawneh government were divided into the following axes, as it was found that the financial and economic axis is the highest with 61% of the total decisions, followed by the administrative axis by 29%, followed by the legislative axis by 27%, then the development and services axis and the appointments axis by 24% for each Finally, agreements and treaties were the subject of 9.5% of the total decisions.

Al-Khasawneh government issued 17 defense orders, 38 statements later on previous defense laws, as they were distributed among the axes by 40% in the axis of development and services, followed by the axis of economic reform and the axis of the rule of law and human rights by 29% for each, and 2% in the axis of administrative reform.

The report preparation team tracked all the activities of the members of the Khasawneh government since its formation until 14 months. The activities that were implemented through the approved sources were collected. The total activities of all members of the government reached 3,023 activities, and 64 field visits by the Prime Minister were monitored, and the most active ministers in terms of field activities; the Minister of Agriculture with 120 field activities, followed by the Minister of Social Development with 108 field activities, and the Minister of Tourism with 91 field activity.

As for appointments, the report preparation team tracked all appointments issued by the Khasawneh government during the first year, where the number of appointment decisions reached 51, and the number of appointees reached 79 persons.

The project team tracked all the committees that the Khasawneh government formed within 14 months. The number of committees formed during the first year was 6 committees.
