Introduction, Methodology, and Report Axes

#### Introduction

Following the formation stage of Jordanian governments; and according to the constitution, the new government is required to submit a ministerial cabinet statement seeking to obtain the confidence of the Council of Representatives, according to the constitutional text governing the process in article 53 of the Jordanian constitution in its third item: «Every formed Council of Ministers shall place its ministerial statement to the House of Representatives within one month of the date of its formation if the House is in session and request the vote of confidence on that statement.» The same article in its item 4 stated: «If the House of Representatives is not in session, it shall be called to convene in an extraordinary session; and the Council of Ministers shall place its ministerial statement and request the vote of confidence on that statement within one month from the date of its formation.


The Ministerial Statement is considered one of the most important tools of democracy in Jordan. The government cannot commence to perform its duties without the confidence of the council selected by the people to represent them in the decision-making process. The ministerial statements importance also lies in requiring governments to submit the programs and plans which it would adopt in managing public affairs and in striving to dedicate the concepts of democracy, reform, and development in various fields, before the Council of Representatives, which, in turn, would identify the way the Council of Representatives members deal with the new government. They decide to grant or withhold confidence based on commitments and programs submitted, and whether or not they are suitable for implementation.

After the cabinet of Prime Minister Omar Al-Razzaz resigned, and on 7 October 2020, His Majesty King Abdullah II commissioned Dr. Bisher Al-Khasawneh to for the next cabinet. After its formation and after its members took the legal oath, the cabinet submitted its ministerial statement before the Council of Ministers on Sunday 3 January 2021 under exceptional conditions, most important of which was the Corona pandemic which affected the Kingdom and the whole world. The government had to submit a statement which was capable of offering serious, quality, and creative commitments to solve pending issues inherited from previous governments, and not to be carried away behind imposing new taxes on sales or to expand the income tax network. After seven days of deliberations, the government received the confidence of the Council of Representatives on 13 January 2021.

This report comes within the framework of the official and popular interest in Dr. Bisher Al-Khasawneh's government performance and the commitments he submitted in his ministerial statement, and the commitments made in the government's response to the council's discussions of the statement. This monitoring report, published by RASED Program for Monitoring Government Performance contains the commitments made by the government over the first 100 days of its formation. These commitments are distributed over seven main axes. The report also includes the decisions issued by the cabinet of ministers, and also includes a survey study conducted during the 100 days? period.

Periodic reports will be published for Jordanian citizens benefit, in line with best international applications in monitoring government performance and to dedicate transparency in public work. The following chart shows the thresholds of Dr. Bisher Al-Khasawneh government.

# Methodology

This report followed a clear research methodology that comprises qualitative and quantitative indicators developed based on RASED's accumulated experience in preparing monitoring reports, while drawing on some international practices which provide monitoring methodologies and scientific indicators to measure and evaluate the level of government performance.

This report was prepared by a team of researchers from Al-Hayat Center — RASED, and a team of experienced independent researchers in government performance research. The work team took a number of steps to prepare the report, including:

- 1. Data-Gathering Stage: this stage was implemented by two separate teams from Al-Hayat RASED, working in parallel to collect data related to each report axis. Reliable sources of information were utilized, namely:
- A. Official Gazette
- B. Prime Ministry's website
- C. Different ministries websites
- D. Ministries social media «Facebook» pages
- E. Jordan News Agency «Petra»
- F. Legislation and Opinion Bureau website
- G. Government's website
- H. Information open source «Google» to which the research team resorted when information was not available through the above sources. This was the last resort to add credibility and reliability.
- 2. Information Verification Stage: After the data gathering stage, a joint session was held between the RASED research team and the independent researchers to review the information gathered and verify its accuracy.
- 3. Information Classification and Analysis Stage: After verifying the accuracy of the information gathered, the report axes were distributed to the different research teams and each team classified the information to the axis under its responsibility. Each team then analyzed this information and drafted the report part related to the axis it is working on. The independent researchers and RASED's research team then met for a comprehensive revision of the report before it was transferred to the language editing and visual organization stage.

Despite the specific methodology used in preparing the report and which ensures an accuracy level of about 95%, the probable error is believed to be at a maximum of about 5%.

## **Report Themes**

#### First: Government Commitments and Promises

#### 1. An Inventory of Commitments and Promises

For the purpose of taking inventory of the government's commitments and promises, the report team traced what was verbally stated by Prime Minister Dr. Bisher Al-Khasawneh in all forums, statements, and plans. The ministerial statement seeking the Council of Representatives' confidence was analyzed and its contents in terms of commitments were extracted. The letter responding to the Council of Representatives' discussions was also analyzed. The team will trace all media interviews and field visits made by the prime minister to monitor commitments made by him.

#### Classification of Commitments:

After taking inventory of the commitments, the report team classified these commitments within 8 axes based on the type of each commitment as follows:

- 1. Development and Services
- 2. Administrative Reform and Fighting Corruption
- 3. Foreign Affairs
- 4. Transparency and the Media
- 5. Political Reform
- 6. Rule of Law and Human Rights
- 7. Economic Reform

#### 2. Tracing the Level of Commitment Implementation

The report team conducted an expanded office research based on sources of information approved by this report to identify the level at which government commitments were fulfilled. This research was conducted by the RASED research team in cooperation with a team of independent researchers. Information was verified and checked over three different stages.

The level at which commitments were fulfilled was identified at three sub-levels selected based on RASED's experience in evaluating government plans and commitments, and based on a number of international standards. These sub-levels are:

- Full Verification: A commitment is granted this level when the following conditions are fulfilled:
- All the material foundations of the commitment were fulfilled

- There was a clear and proven outcome of the commitment
- In-Progress Implementation: A commitment is granted this level when the following conditions are fulfilled:
- One or more of the commitment's material foundations have been started
- There was clear and documented evidence of implementation aimed at fulfilling the commitment
- Did not Start: If the research team arrived at any evidence of starting any foundation of the commitment, this level of commitment is given.

#### Second: Cabinet of Ministers Decisions

The research team traced and took inventory of the cabinet of ministers decisions issued during the cabinets meetings and were officially published on the prime ministrys website and the e-governments website. The decisions were classified according to the following axes:

- 1. Public Services and Development
- 2. International Conventions and Treaties
- 3. Legislative
- 4. Appointments
- 5. Administrative
- 6. Financial and Economic

### **Third: Appointments**

The research team traced the cabinet of ministers decisions and decisions related to appointments in high leadership positions were discussed. The team then research the professional backgrounds of those appointed, showing whether the appointee had been working, before being appointed, in the private or public sector.

Executive Summary

RASED Program for Monitoring Government Performance issued its first report on monitoring the performance of Dr. Bisher Al-Khasawneh's government after 100 days of its formation. The report period continued from 12 October 2020 to 20 January 2021. A methodology was adopted that follows the commitments presented by the government during the first 100 days. They were distributed over seven main axes and the achievements of commitments will be verified in the periodic report to be issued by RASED on monitoring government performance. The report also included the decisions taken by the government through the cabinet of ministers. They were distributed over a number of axes. The report presents the appointments approved through the cabinet of ministers, and an online survey on the 100 days of Al-Khasawneh government. The respondent sample reached 1722 respondents distributed throughout the Kingdom's governorates.

Dr. Amer Bani Amer said that the study results showed that 33.5% of Jordanians believed that the ministerial team was unable to shoulder the responsibilities during the first 100 days. 27.5% of Jordanians believed that the ministerial team was poorly capable of assuming their responsibilities. 30% believe that the ministerial team was moderately able to shoulder its responsibilities while 9% said that the ministerial team was very capable of shouldering its responsibilities during the first 100 days of the governments life.

The results related to Jordanian opinions on the need to make a cabinet reshuffle after the 100 days showed that 44.5% of Jordanians believed that there is an urgent need for a reshuffle. 23.4% of Jordanians believed that there is a moderate need for a reshuffle, while 7.6% said that there a small need for a reshuffle. Those who believed that there is no need for a reshuffle were 24.5% of Jordanians.

Regarding citizen satisfaction with the way Dr. Bisher Al-Khasawneh's government dealt with the Corona pandemic, results showed that 12.3% of Jordanians are satisfied to a large extent with how the government dealt with the Corona pandemic, 34.8% felt medium satisfaction, while 24% of Jordanians felt dissatisfied with the way the government dealt with the Corona pandemic.

Regarding the effect of the accumulating challenges from previous governments facing the government in assuming its responsibilities, results showed that 50% of Jordanians believed that the challenges affected the government to a large extent, 26.6% saw that the accumulated challenges will have a weak effect on the governments abilities to shoulder its responsibilities, while 12.4% of Jordanians felt that the accumulated challenges had no effect.

Regarding the commitments the government undertook, it was evident that they reached 204 commitments, which were extracted from the ministerial statement submitted by the government before the Council of representatives, the government's response to the council's discussions of the ministerial statement, and a number of meetings held by the government with different institutions and parties. The commitments were distributed over seven main axes, the top of which was the development and services axis at 52% of the total commitments, followed by the economic reform axis at 21%, administrative reform and anti-corruption at 14%, the rule of law and human rights at 6%, transparency and the media at 3% and the political reform and foreign affairs axes at 2% for each.

Regarding the cabinet of ministers<sup>3</sup> decisions, they were 87 decisions distributed over 6 main axes. The legislative axis was the highest in terms of decisions at 34 decisions, followed by the financial and economic axis at 19 decisions, the appointments axis at 12 decisions, the administrative axis at 11 decisions, the international conventions and treaties axis at 8 decisions, and the services and development axis at 3 decisions. It is noteworthy that the Prime Ministry's Facebook page, the e-government's website, and official News Agency were used to monitor and collect decisions. Regarding the appointments approved by the cabinet of ministers within upper-level positions, they reached 10 appointments. A Managing Director was appointed for the Jordan Cooperative Corporation, a Secretary General was appointed for the Ministry of Local Administration, a part-time Executive Manager was appointed for the Economic and Social Council, and an acting Director was appointed for the Investment Authority. The Board of Directors of the Radio and Television Corporation was reshuffled, two members were appointed to the Higher Education Board, an Ambassador was appointed to Egypt, and a Secretary General for Pandemic and Communicable Diseases at the Ministry of Health was appointed.

RASED points out that it will issue its periodic reports on government performance, to include the level of performance, and a verification of the implementation of the commitments offered by the government in a transparent manner. It will also publish field and office activities performed by members of the cabinet of ministers cumulatively.
